Marshall Township Regular Board Meeting – Marshall Township Hall

February 20, 2023

The meeting was called to order at 7:00 p.m. by Supervisor David Bosserd.

Present: Albaugh, Bosserd, Lyng, Roberts and Walsh

The Pledge of Allegiance was led by Duane Sly.

Motion by Lyng, supported by Walsh, approve the proposed meeting agenda with the addition of calling a special meeting for consideration of Freedom of Information Act denial appeals. VOICE VOTE: all YES. CARRIED.

AUDIENCE COMMENTS AND PUBLIC HEARINGS: Supervisor Bosserd announced that the public hearings on the four proposed land transfer agreements as referred to in the public notice (attached) and audience comment time were open. The Clerk was asked if there were written comments and he indicated there were several and they were made part of the public record (attached). Supervisor Bosserd read an introduction concerning procedures that apply during the making of comments and the purpose of the hearings (attached). 30 persons made comment, 10 of whom identified themselves as Marshall Township residents. 26 spoke either in opposition to the transfers, opposition to the industrial development on the property or in favor of a referendum on the transfers. During the public hearing a Marshall Township resident was called to order several times for interrupting other speakers and disruptive conduct. At approximately 8:20 p.m. Supervisor Bosserd directed the resident to leave the meeting for causing a disturbance. When the Sheriff Deputy repeatedly asked the cooperation of the resident in leaving as directed, the resident refused. The Deputy removed the resident from the meeting hall. The public hearing and meeting resumed. At approximately 9:05 p.m., no further persons indicated they wished to speak, Supervisor Bosserd whereupon declared the public hearings and audience comment time concluded.
