Marshall Area Fire Fighters Ambulance Authority Millage Renewal Proposal

This proposal will allow the Marshall Area Fire Fighters Ambulance Authority to continue the same number of mills required to be levied on all property at .50 mills, to enable it to continue to operate as an ambulance authority. This is not an increase in tax over the same tax that has been levied for the past ten years, but a continuation of the same operation millage.

Shall the existing tax rate limitation previously approved by the electors of the Marshall Area Fire Fighters Ambulance Authority, Calhoun County, Michigan, .50 mills (\$0.50 on each \$1,000.00 of taxable valuation) for a period of 10 years, 2014 through 2023, inclusive, be renewed at .50 mills (\$0.50 on each \$1,000.00 of the taxable valuation) for a period of 11 years 2024 through 2034, inclusive, as a renewal millage to provide operating funds for the Marshall Area Fire Fighters Ambulance Authority. It is estimated that the revenue the Ambulance Authority will collect, if the millage is approved and levied in the 2024 calendar year, is approximately \$415,000.00.

MARENGO TOWNSHIP ROAD MILLAGE RENEWAL PROPOSAL
Shall Marengo Township impose a renewal of 1 mill (\$1.00 per \$1,000.00 of taxable value) in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution and levy it for five years, 2024 through 2028, inclusive, for township road improvement and repair purposes, which one mill increase will raise an estimated \$112,612.86 in the first year the millage is levied?

Re: Calhoun County Early Voting Center(s)

Dear Jeff:

As you know, at the November 8, 2022, general election, Michigan voters adopted Proposal 2022-2 which, among other things, added language to the Michigan Constitution providing for early voting. The provision regarding early voting, which is now found in Article II, Section 4(m), states in relevant part that:

...An early voting site is a polling place and shall be subject to the same requirements as an election day polling place, except that an early voting site may serve voters from more than six (6) precincts and may serve voters from more than one (1) municipality within a county. An early voting site shall also be subject to the same requirements as an election day precinct, except that any statutory limit on the number of voters assigned to a precinct shall not apply to an early voting site....

To help municipalities within Calhoun County manage early voting more efficiently, and to help reduce costs associated with providing an early voting center, my office is formulating plans to offer early voting center(s) to serve all municipalities in Calhoun County that choose to participate. To aid our planning in this regard, I am writing to each municipal clerk within Calhoun County to determine which municipalities would intend to participate in the proposed consolidated early voting center(s).

Each municipality participating in a consolidated early voting center would be required to reimburse the County for costs associated with managing the early voting center(s) on a pro-rata method to be determined and agreed upon in a written contract to be subsequently prepared and signed by each participating municipality.

If your municipality is interested in participating in a consolidated early voting center as generally described above, please indicate by signing the attached letter of intent on behalf of your municipality and returning it to my attention no later than Wednesday, July 19, 2023.

By signing this letter of intent, the parties hereto are not bound to enter into any ultimate contractual agreement for the provision of and participation in a consolidated early voting precinct. This letter of intent serves only as a general expression of intent by the parties, and any binding commitment with respect to the matters described herein will result only from the execution of a written agreement signed by the authorized officials of the contracting parties. This letter merely sets forth the mutual present intent of the parties and does not in any manner constitute a binding agreement as to any party.
